Official Straight Outta Compton Flyaway Rules ("Rules")

SWEEPSTAKES DESCRIPTION:

(Total ARV = \$2,500) ("Grand Prize").

If the Grand Prize winner resides within 400 miles of Los Angeles, CA (as determined by Sponsor (defined below) the winner will receive Two Thousand Five Hundred Dollars (\$2,500) and two (2) tickets to the "Straight Outta Compton" movie premiere in Los Angeles, CA (Date TBD).

Listeners of the following stations: KJLH/Los Angeles; WHTA/Atlanta; WERQ/Baltimore; WWIN-FM/Baltimore; WENZ/Cleveland; KBFB/Dallas; KROI/Houston; KBXX/Houston; WGPR/Detroit; WPHI/Philadelphia; WQOK/Raleigh; KBXX/Houston; WHHL/St. Louis; and WKYS/Washington DC (collectively the "Participating Stations") who are legal residents of the United States residing within the metropolitan area of one of the Participating Stations and are 21 years of age and older at time of entry will be able to take part in this Sweepstakes. ELIGIBILITY RESTRICTIONS:

- 1. The Sweepstakes is open to listeners of the Participating Stations who at time of entry are 21 years of age and older and are legal residents of the United States residing within one of the following metropolitan areas: Los Angeles, CA; Atlanta, GA; Baltimore, MD; Cleveland, OH; Detroit, MI; Houston, TX; Dallas, TX; Raleigh, NC; St. Louis, MO; Philadelphia, PA; and Washington, DC.
- 2.
