

Hello Beautiful's IMAN Cosmetics Deals Weekly Sweepstakes OFFICIAL SWEEPSTAKES RULES

HOW TO ENTER / EXECUTION:

Readers of HelloBeautiful.com who are legal residents of the United States, and are 18 years of age and older will be able to take part in this Sweepstakes. To participate in the Sweepstakes, Readers must do the following:

1. Sweepstakes participants must register online through Hello Beautiful's website located at www.HelloBeautiful.com.
