OFFICIAL SWEEPSTAKES RULES**

SWEEPSTAKES DESCRIPTION:

The InstaLove Dating Sweepstakes (“**Sweepstakes**”) will begin on Thursday, October 23, 2014 at 12:00 am Eastern Standard Time and end Friday, November, 14, 2014 at 11:59 pm Eastern Standard Time (“**Sweepstakes Period**”). This Sweepstakes will be conducted exclusively online. Four (4) winners will each be awarded the opportunity to go on one (1) first date with a participating “Eligible Bachelor” and shall receive the following to be used on the first date: one (1) Uber voucher; One (1) pair of movie tickets to see the Movie “Beyond the Lights”; Travel to and from date from origin city; and one (1) \$200.00 Gift Card to spend on the First Date (“**Weekly Prize**”). Weekly Prize approximate retail value (“**ARV**”) is \$1,000.00 USD. Total Sweepstakes ARV is \$4,000.00. Eligible Bachelors are single men between the ages of 21 and 38 selected by the Sponsor who are compensated for participation in this Sweepstakes.

SWEEPSTAKES ELIGIBILITY

1. Entrants must be legal residents of the 50 United States or the District of Columbia, 21 years of age or older, and complete the following actions below in order to enter and take part in this Sweepstakes.

Readers of HelloBeautiful.com (“**Participating Website**”) must do the following:

1. Visit a Participating Website.

2. Visitors who elect to enter the Sweepstakes (“Entrants”) must have an Instagram account.
3. Visitors must submit a photo of themselves, via Instagram, using the hashtag #InstaLoveDate via their Instagram account.

7. Winners will be selected from Qualified Entrants. A Qualified Entrant is an Entrant who satisfies the Eligibility Requirements set forth above and Eligibility Restrictions set forth below, and will be notified on the following dates:

 - iv. Drawing Date 4: To participate, all Entrants must submit entries by 11:59 pm Eastern Standard Time on November 10, 2014. Drawing Date 4 Winner will be notified on: Tuesday, November 11th, 2014
8. Winners will have 24 hours from notification to claim Weekly Prize or Weekly Prize will be forfeited.

ELIGIBILITY RESTRICTIONS:
